

**MINUTES OF SPECIAL TOWN MEETING  
OF THE ELECTORS OF THE TOWN OF SAUKVILLE, OZAUKEE COUNTY**  
November 16, 2004 following the Budget Presentation

Town Chairman Kadow convened the special town meeting of the electors pursuant to Section 60.12(1)(c) of Wisconsin Statutes for the following purpose:

- 1. To adopt the 2004 tax levy to be paid in 2005 pursuant to Section 60.10(1)(a) of Wisconsin Statutes.**

Ed Liesenberg moved to approve the levy of \$273,100 as proposed; Barbara Jobs seconded. By show of hands, the motion carried by a count of 19 to 11.

Bill Niehaus moved to adjourn; Kay Danielson seconded; motion carried by voice vote.

Wollmer moved to approve as written; Niehaus seconded; motion carried unanimously.

- 4. Discussion/action on 2005 Proposed Budget.**

Kadow moved to approve the 2005 budget as presented; Wollmer seconded; motion carried unanimously.

- 5. Status of sign at Hwy 33 and Birchwood.**

Kadow updated the board that the non-conforming sign should be removed in January 2005 per a prior agreement with the owners.

- 6. Town Constable's Report**

Dickmann reported that the manure problem on Cold Spring Rd. has been resolved. He also stated that he was working to resolve a "junk" problem on Hwy O and would report at the next meeting.

- 7. Roads Report**

- a. Status on complaint regarding truck traffic on Blueberry Rd.**

Kadow noted that this issue was addressed by a previous board with no action taken. Henry Saupe addressed the board and stated that he has observed a four axel milk truck that daily traverses a section of Blueberry Rd. which has standing water on each side year-round. The section is between Meadowlark and Hawthorne Roads and the truck is severely damaging the roadbed. He indicated that the truck could just as easily take Hawthorne to Hwy 57 to get to Fredonia. He asked the board to post a weight limit of 6 tons to limit road damage. Larry Beverung supported Saupe and forecasted considerable maintenance expense if the practice continued. Niehaus then moved to post a weight limit of 6 tons beginning north of Hamm's dairy farm drive to Meadowlark Rd. ; Wollmer

seconded; motion carried unanimously. Staff will draft an ordinance accordingly.

Kadow commended the poll workers for their efforts at the recent election.


### 12. Items from the floor

Patty Charnitz questioned why the front door was locked at the election. Clarke stated that it was an oversight and it was unlocked shortly after the polls opened.

A citizen questioned the BOG assessment and Kadow summarized the status of the case. Eileen Hoffmann questioned the status of the Park Trust Fund. Clarke responded that the fund currently has a balance of \$9,451. John Yeager questioned the status of the Payne & Dolan land transfer and Niehaus said he would check into it. He also questioned the liability of the town associated with the parcel. Niehaus replied that the law limits towns liability should not be of concern. Walter Wilsnack questioned the amount of legal expense associated with the BOG protest and Kadow stated that it would be paid by the town's insurance company.
